

## **Principles of Excellence**

## For Institutions Serving Service Members, Veterans, Spouses and Family Members

- Maximum amount of Title IV, HEA aid available to students is \$19,878
- Borrower may qualify for Title IV, HEA loans.
- Terms and conditions of the Title IV, HEA loans may be more favorable than the provision of private education loans; and
- An explanation regarding the benefit programs offered by the Department of Veterans Affairs and Department of Defense is as follows:
- o If you served on Active Duty, you might be eligible for education
- benefits offered by the Department of Veterans Affairs. For example, the Post-9/11 GI Bill
- o provides financial support for educational and housing expenses to individuals with at least 90
- o days of aggregate service after September I 0, 2001, or individuals discharged with a service-
- o connected disability after 30 days. You must have received an honorable discharge to be eligible for the Post-9/11 GI Bill.
- If you are currently serving in the military, you may be eligible for funding offered through the Department of Defense Tuition Assistance program. Check your eligibility status and the
- o amount for which you qualify with your Service prior to enrolling.
- o If you are the spouse or child of a service member who is serving on active duty Title 10 orders in the paygrades of El-ES, 01-02, or Wl-W2, you may be eligible for financial assistance from the Department of Defense for education, training, and/or the occupational license and
- credentials necessary for a portable career.
- If you are the spouse or child of a service member, you may be eligible for transfer of the service member's Post-9/11 GI Bill benefits to you.
- Private student loans contrast from Title IV, HEA loans by:
  - o Title IV, HEA loans may have a lower interest rate.
  - Deferment while attending school until 6 months after graduation or last date of attendance for Title IV, HEA loans.
  - Repayment options are available.
  - o No credit check for students apply for Title IV, HEA loans.
  - Private student loans may require a co signer.
